Seaport and Airport of Entry in UAE:

All our shipments to the UAE will need to be sent only via **Port of Entry Jebel Ali for Sea shipments or Airport of Entry Dubai International Airport for Air shipments.**

Please **AVOID** sending shipments via Abu Dhabi seaport / airport, airport Dubai World Centre (DWC or Maktoum Airport) or any other seaports / airports in the UAE as additional charges and documentation will be applicable / required if shipments will arrive at other seaport / airport.

Documents Required for Import Clearance to be provided by the Origin Agent:

Please note that Pre-alert advising shipment details 7 days prior to arrival to Port / Airport of Entry.

Effective 16th July 2014, Emirates Airlines is only offering 24 Hrs free storage time with a minimum of US\$ 275.00 per Day (irrespective of the weight) & US\$ 0.07 / kg above the minimum point). To avoid any additional charge, we DO NOT RECOMMEND TO USE EMIRATES AIRLINES for airfreights to UAE.

If Sea shipments will have House Bill of Lading, please do ensure to forward the Master Bill of Lading. Exchange Bill of Lading charges will be billed back to origin agent accordingly.

- 1. Airway Bill / Bill of Lading stating "Used Personal Effects and Household Goods" in the "Description of Goods" column (Telex / Express release for sea shipments is more preferred);
- 2. Clear Copy of detailed packing inventory;
- 3. Motorized vehicles should be accompanied by registration certificate, insurance policy and invoice. Description of vehicle / motorbike should be noted under the Bill of Lading Description: Chassis Number, Engine Number, Year & Make, Model, Color of the Motorized Vehicle.
- 4. For Diplomatic shipments, please ensure to note

Documents Required from the Consignee / Owner of the goods for Import Clearance:

- A. For Foreigners shipping used Personal Effects and House hold goods to the UAE
 - A clear copy of consignee's passport (only the personal identification page, photo, and signature one used for the Visa)
 - A clear copy of consignee's UAE residence visa;
 - Original signed Customs and Excise Authorization Letter (2 forms) completed by the consignee (see pages 4 6 for shipment via Sea and pages 7 8 for shipment via Air)

*If UAE Residence Visa is not available yet, consignee will need to present the following additional documents:

- A clear copy of consignee's U.A.E. employment visa (A4 size in Arabic and English);
- A clear copy of consignee's immigration entry stamp as placed in the client's passport upon entering the UAE.
- 2 original copies of Letter of Undertaking from the employer (authorized signatory with company letterhead and seal)

B. For UAE or GCC national* shipping used Personal Effects and House hold goods to the UAE

*GCC National from Saudi Arabia, Bahrain, Oman, Qatar and Kuwait only

- A clear copy of consignee's passport (only the personal identification page, photo, and signature)
- A clear copy of consignee's UAE Emirates Identification Card
- Original signed Customs and Excise Authorization Letter (2 forms) completed by the consignee

C. For Diplomatic clients shipping used Personal Effects and House hold goods to the UAE

- A clear copy of consignee's passport (only the personal identification page, photo, and signature)
- A clear copy of consignee's diplomatic Identification Card
- Original Exemption (Arabic) Letter from the Ministry of Foreign affairs (to be provided by the Consulate)
- Original signed Customs and Excise Authorization Letter (2 forms) completed by the consignee

Please make sure to check with the Ministry at Origin, the contact person at the consulate in UAE as we need to provide the copy of the Bill of Lading / Airway Bill to the Consulate prior to arrival of the shipment for processing of the Exemption Letter. Processing for the Exemption Letter with the Ministry of Foreign Affairs in UAE may take some time, hence please do expect that shipments may incur demurrage and port storage.

Some consulates will require a different format on the consignee details, please do reconfirm with the Ministry and inform Fusion Relocations import coordinator in advance to assist with checking with the consulate in UAE.

Any diplomatic shipments may still be subject for customs inspection. It is important that the Exemption Letter will need to specify the goods being shipped into the UAE and to notify Fusion Relocations in advance if there will be any restricted items that may be included in the shipment.

U.A.E. CUSTOMS CLEARANCE AND INFORMATION:

With regards to customs clearance, please note that it takes approximately 4-7 customs working days for Sea shipments and 3-5 working days for Air shipments to clear customs after shipment arrival, subject to having all the import clearance documents in place prior to shipment arrival. Customs clearance can only take place once the customer provides all the necessary import clearance documents to Fusion Relocations.

All sea shipments coming into Jebel Ali port are subject to 5-day free period at the port. For shipping line free period please contact your origin shipping.

Please note that Friday is a weekend in Dubai and for Dubai Customs. Hence, no customs clearance and inspection can take place during this day.

The consignee's presence <u>maybe</u> required for Customs clearance in case if contrabands are found in the shipment (note that in most cases shipper is NOT present).

- Personal effects and household goods are subject to physical inspection by UAE customs therefore any customs related charges can only be informed once the inspection is completed.
- Books, literature, CDs, DVDs, computer software may be detained by Customs authorities and could be subject to screening. This process through the Ministry of Information takes approximately 3 weeks. Material deemed suitable will be returned to the consignee. Material deemed unsuitable will be confiscated and either destroyed or shipped to origin at the consignee's expense.
- Customs duties on motorized vehicles, new or commercial items are 5% of the customs assessed value + 5% UAE VAT.
- Please be informed that UAE Custom is applying VAT of 5% on HHG import shipment based on declared/CIF value from 1st January 2018.

U.A.E. PROHIBITED ITEMS LIST:

Weapons, firearms (real or ornamental), ammunition, fire crackers, swords, daggers, spears etc., military uniform & equipment, alcohol, spirits, narcotics of all kinds, even poppy seeds and flowers, leaves etc., banned drugs and medicines, medicines in large quantities, even obtained under prescription and for the consignee's use, radio transmitter or communication equipment, any kind of gambling games, statues and figures of animals with religious undertone, carvings and statues of humans, especially in nude, pornographic materials, food stuff in large quantities, lvory products, Remote or cordless telephones, Swords or Spears, Walki-talkie and satellite dishes, drones, products of Israeli origin or items on the Israeli blacklist, religious books other than dealing with Islamic beliefs, controversial political literature and materials contrary to an Islamic State's principles.
